

STAG INDUSTRIAL ANNOUNCES ATM ACTIVITY FOR THIRD QUARTER 2016

Boston, MA – October 13, 2016 - <u>STAG Industrial, Inc.</u> (the "Company") (NYSE:STAG), a real estate investment trust (REIT) focused on the acquisition and operation of single-tenant, industrial properties throughout the United States, today announced that, under its "At the Market" stock offering program ("ATM"), the Company issued an aggregate of 4,201,500 shares of common stock during the third quarter of 2016 at a weighted average offering price per share of \$23.97, receiving gross proceeds of approximately \$100.7 million and net proceeds of approximately \$99.2 million. The Company used the net proceeds of the ATM to fund acquisitions, repay indebtedness, and for working capital and other general corporate purposes.

A registration statement relating to these securities has been declared effective by the Securities and Exchange Commission.
